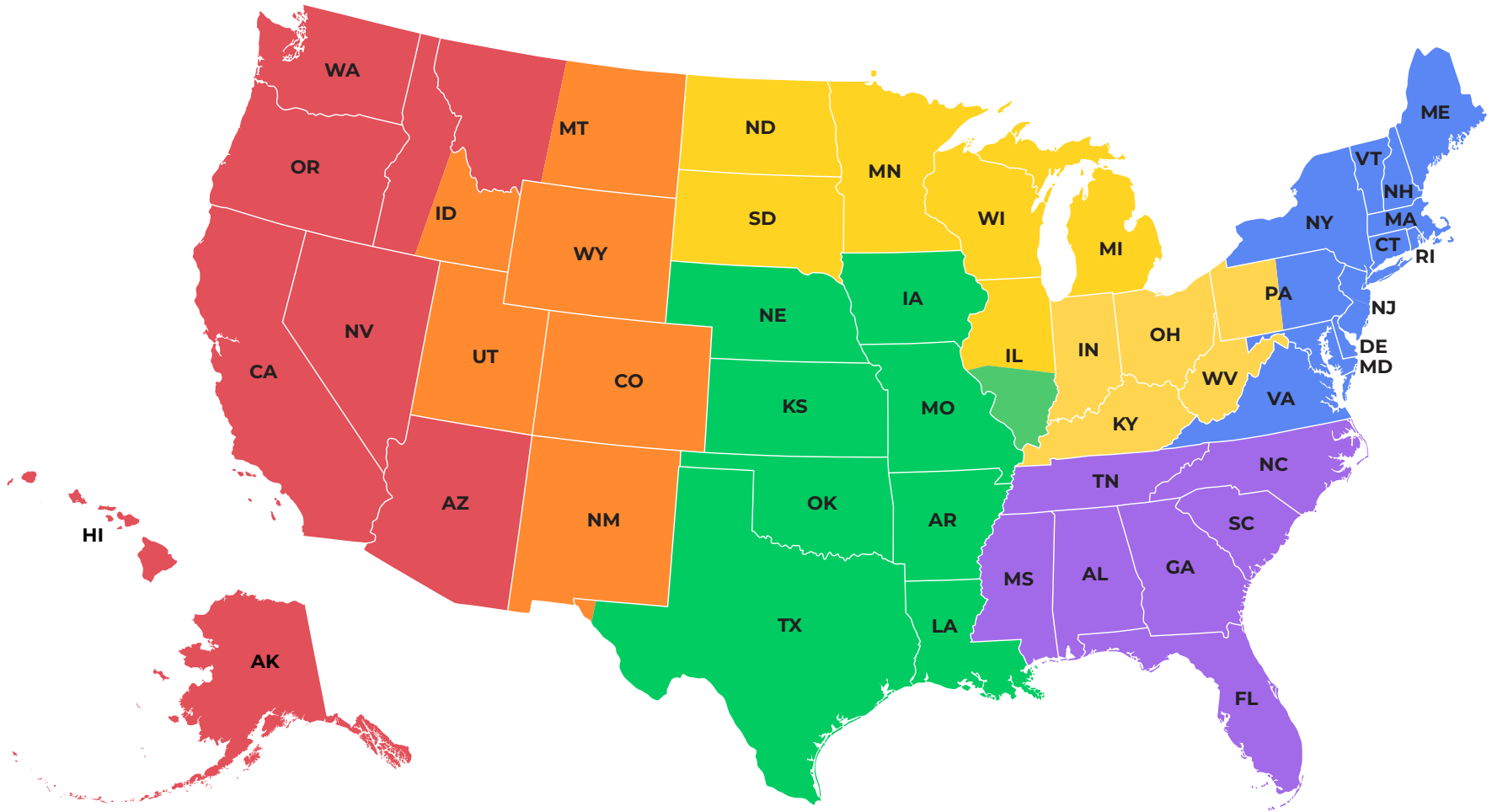


# UNITED STATES TERRITORY MAP
